In case of injury, accident or illness, I do understand that Hound Dog Hotel LLC will take the very best care of my dog(s)/cat(s) and every precaution for the health and welfare of my dogs(s)/cat(s).

- 1. I agree to pay the rate for boarding effective on the date the dog/cat is checked into the kennel.
- 2. I further agree to pay all costs and charges for special services requested and all necessary costs for the dog(s)/ cat(s) during the time said dog/cat is in the care of the kennel. Grooming is solely based on availability.
- 3. By signing this contract and leaving my dog(s)/cat(s) with the kennel, I certify to the accuracy of all information given about the said dog(s)/cat(s).
- 4. I further understand and agree that in admitting my dog(s)/cat(s) to Hound Dog Hotel LLC, staff have relied on my representation that my dog(s)/cat(s) is/are in good health and have not harmed or shown aggressive or threatening behavior toward any person or any other dog/cat. I hereby indemnify Hound Dog Hotel LLC, its owners and representatives, with regard to any claims arising from the aggressive behavior of my dog(s)/cat(s).
- 5. I agree Hound Dog Hotel LLC will not be responsible or liable for lost, stolen or damage to personal property belonging to me.
- 6. I understand and agree that Hound Dog Hotel LLC and their staff and volunteers, will not be liable for any problems which develop, including but not limited to, loss by fire, theft, running away, death or injury, or natural acts of God and I hereby release and discharge Hound Dog Hotel LLC, its owners, employees and representatives from any and all claims, damages, liability and/or causes of action of any kind arising from my dog(s)/cat(s) attendance at the kennel except where any such loss is caused by negligent or intentional act of an employee or representative of the kennel.
- 7. I specifically represent to Hound Dog Hotel LLC that the dog(s)/cat(s) have not been exposed to rabies or distemper within a 30 day period prior to boarding and that the dog(s)/ cat(s) has all the necessary vaccinations (Rabies, Distemper (DHLPP), Bordetella, and RCP). Evidence of these vaccinations has been provided at time of boarding.
- 8. I agree that Hound Dog Hotel LLC will do their best to provide my animal with shots or medication as needed supplied by me for an extra charge of \$3.00 per visit, but in the event that the dog(s)/cat(s) reject shot or medication, I will not hold Hound Dog Hotel LLC reliable.
- 9. I understand that the dog(s)/cat(s) must be treated for fleas and ticks prior to arrival. If fleas or ticks are found on the dog(s)/cat(s) during boarding the staff of Hound Dog Hotel will treat dog(s)/cat(s) at the owner's expense.
- 10. All charges incurred shall be payable upon pickup of dog(s)/cat(s). The kennel shall have and is hereby granted lien on the dog(s)/ cat(s) for any and all unpaid charges resulting from boarding dog(s)/ cat(s) at the kennel. All daycare dogs must be picked up by the end of business day. If not picked up by closing time, the dog will be placed in our boarding facility and the owner will be charged \$16.00 for a night of boarding and will not be available for pick up until next business day.
- 11. Hound Dog Hotel will make every effort to keep all dogs/cats safe however I recognize that there are inherent risks of illness or injury when dealing with animals. Such risks include, but are not limited to problems from rough play and canine cough.
- 12. I am aware that my dog will co-mingle with dogs owned by different owners in a supervised environment unless otherwise specified during the consultation.
- 13. If my dog/cat becomes ill I understand that I will be notified pursuant to the contact information I have provided when my dog/cat was checked into the kennel. If I do not immediately notify Hound Dog Hotel LLC regarding which measures I wish to be taken or in the event emergency action is required, in the sole discretion of Hound Dog Hotel LLC, a veterinarian may be contacted and my dog/cat may be evaluated by such veterinarian or transferred to the veterinarian as deemed necessary. I agree to promptly pay for any such expenses incurred in connection with such veterinarian services.
- 14. The owner agrees that by signing the Care and Authorization form one time that it remains in full effect and force each and every time the owner brings the owner's dog(s)/cat(s) to Hound Dog Hotel LLC for any of our services.
- 15. Please cancel bookings as soon as possible. Cancellations and No-Shows that take place less than 48 hours of the scheduled date will be subject to a \$30.00 non-refundable fee.
- 16. Owner agrees to allow Hound Dog Hotel LLC to use my dog(s)/cat(s) name and any images or likeness thereof, including photos or videos of my dog taken while they are attending services at Hound Dog Hotel LLC, in any form or format, for use, at any time, to be posted on the Hound Dog Hotel LLC website, or to be used in any media or marketing.
